 Rates on current policy increased significantly. Council decided to switch to RS24 policy with
 Blue Cross/Blue Shield; with a higher deductible and lower premium.
- MOTION: Upon a motion made by Councilmember Bradford and a second by Councilmember Cowdery, the Council voted five (5) for and none (0) opposed to approve Blue Cross Blue Shield RS24 Policy as employee health coverage for FY 2011/2012.

 After brief discussion, Council set the date for October 22, 2011
